to attend the international academic conference "BRATISLAVA LEGAL FORUM 2013"

The Faculty of Law, Comenius University in Bratislava and the Faculty of National Economy, University of Economics in Bratislava extend an invitation to attend the first annual international academic conference **BRATISLAVA LEGAL FORUM 2013** to be held **on 10 and 11 October 2013** at Comenius University and Economic University in Bratislava under the auspices of Robert Fico, Prime Minister of the Slovak Republic.



The Conference is an occasion to honour **the 110th birth anniversary of the prominent Slovak jurist Professor Imrich Karvaš**, the Faculty of Law professor, notable also as one of the founders of the School of Business set-up in 1940, which was the predecessor of the present University of Economics in Bratislava.

The main aim of the Conference is to link the sciences of law and economics with legal and economic practice, addressing the current economic and legal issues in an effort to deal with the present economic crisis, and providing a forum for expert discussions.



In accordance with its aim, the Conference will be divided into the **Plenary Session** and **11 Parallel Sessions** with specific subject-matters focusing on the particular issues of the relevant area of law.
