INDEPENDENT VISITING RESEARCHERS

The Unidroit Library is a study centre both for those who take part in Unidroit's legislative activities and for visiting researchers. It is a meeting place for people from different legal cultures, has borne witness to more than 90 years' worth of legislative work by Unidroit, and thus offers a unique research opportunity in the exceptional setting of Villa Aldobrandini located in the centre of Rome. Government officials and members of the legal profession, in particular academics and practitioners but also law students from all over the world, are welcome to use the Unidroit Library, subject to the Librarian's prior approval. Researchers are invited to consult the online catalogue before applying. Projects relating to Unidroit's past legislative activities as well as projects on the current Unidroit Work Programme are given special attention. A good working knowledge of English and/or French is indispensable.

RESEARCH SCHOLARSHIP PROGRAMME

The *Scholarship Programme*, which is for top-level lawyers primarily from developing countries or countries in economic transition, has hosted since 1993 nearly 300 researchers from over sixty countries. Scholarships are for an average period of two months (according to the particular conditions attached to each scholarship). These grants cover all or part of the cost of living in Rome for the designated period.

Candidates are selected using the following criteria (subject to, in addition, possible donor requirements):

- the subject of the candidate's research project, which must relate to uniform law / international private law, with preference being given to subjects connected to the current UNIDROIT Work Programme;
- the project's potential for practical application in the beneficiary's country of origin, with preference being given to projects relating to the drafting of national laws or to the promotion of uniform law instruments;
- the candidate's qualifications ("graduate" or "post-graduate") and position (academic, civil servant, judge, practitioner); and
- o a good working knowledge of English and/or French.

Candidates who are not granted a scholarship may nevertheless be accepted to conduct independent research. In that case, they may obtain a letter from the Institute, which can be used in support of their own requests to potential sponsors to finance their stay in Rome.
